We will process your request in accordance with the relevant legal regulations without undue delay and we will inform you about its processing no later than 30 days after receiving such a request. (This period can be extended by another two months in certain cases. For example, due to great complexity and possibly a large number of such applications to be processed.)

## **Processing purposes**

We process your personal data for the following purposes:

- contacting based on filling out the contact form on our website (hereinafter referred to as "Contacting the client")
- on the basis of our legitimate interest and to keep the history of your communication for the purpose of improving services and targeting offers and marketing campaigns (hereinafter referred to as "Improvement of Services")

## **Scope and period of personal data processing**

We will process only the information about you that we absolutely need for our aforementioned purposes. The scope and duration of processed data varies according to the purposes of their use.

For the purpose of contacting the client and improving services, we will mainly process the following data about you for a period of at least 3 years:

Name, surname, address, title

Birthdate

Permanent residence

Telephone number

Email address

## **Processing time**

We work with your personal data:

- for the time required to fulfill the relevant purpose
- for the determination, exercise or defense of legal claims.

After the end of the processing purpose and the end of the specified period for the processing and storage of personal data, your data will be securely deleted, or destroyed, or anonymized.

## **Your rights**

Everyone has the right to know how we handle their personal data. Therefore, you can of course contact us if you want to exercise any of the following rights:

The right to access personal data,

The right to repair or addition,

The right to erasure,

Right to restriction of processing,

The right to data portability,

The right to object

The right not to be the subject of automated individual decision-making with legal or similar effects, including profiling.

Right to complain - if you have a problem, please contact us first and we will do everything we can to help you resolve the problem. However, if needed, you can of course contact our supervisory authority, which is the Office for Personal Data Protection.

## **Transfer of personal data to third parties**

As part of our activity, your personal data may be provided:

- to entities given by law, e.g. courts, investigators, judicial commissioners, etc.),
- processors who guarantee technical and organizational security of personal data protection (e.g. communication systems, etc.).

Personal data are transferred to third parties only to the extent necessary for the fulfillment of the given purpose.

Our Company only cooperates with processors who provide sufficient guarantees of personal data protection by implementing appropriate technical and organizational measures so that the processing meets legal requirements. With these processors, the Company has always concluded a relevant contract on the processing of personal data.

## **Recipients of your personal data**
